Trusted Traveler Programs

The Quickest Way to Cross!

If you're a frequent border crosser who's looking for a way to speed up your entry into the United States, consider joining a Customs and Border Protection Trusted Traveler program. A small fee, a background check and an interview are usually all that's required. Filling out the application takes just a few minutes.

Approved commercial truck drivers (FAST), air, sea and highway travelers entering from Canada (NEXUS), and highway and pedestrian travelers entering from Mexico (SENTRI) - all enjoy the benefit of automated border clearance through dedicated commuter lanes.

Fees vary by program and program-specific restrictions apply. NEXUS and northern border FAST are jointly administered by CBP and the Canada Border Services Agency, which independently approve program participation based on a common application. Use of the FAST commercial truck lane requires participation in the Customs - Trade Partnership Against Terrorism (C-TPAT) by parties other than the driver.

Advisory Notice:

CBP trusted traveler credentials use radio frequency identification technology (RFID). Program participants should be aware that 1) all applicant data is stored in a secure CBP database; 2) no participant data is stored electronically on the program credential or transmitted with the RFID; 3) RFID technology permits CBP to make a record of the date and time an individual member/user crosses the border; and 4) used in combination with the biographic data previously provided to CBP by the individual member/user during the application process, RFID technology facilitates CBP queries of other law enforcement databases to verify the participants's continued program eligibility and status as a current member in good standing each time entering the United States.
